# **Hurricane Sandy Oversight**

We completed 25 oversight projects related to the \$787 million in funding the Disaster Relief Appropriations Act of 2013 (Pub. L. No. 113-2) provided to the U.S. Department of the Interior (DOI) for Hurricane Sandy recovery efforts.

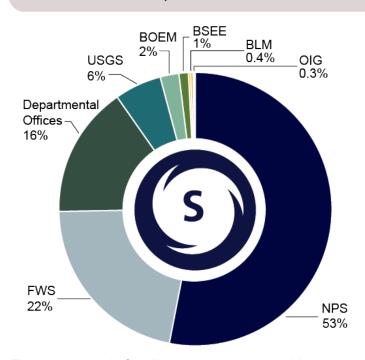
Hurricane Sandy struck the mid-Atlantic and northeastern coastlines in October 2012. It was the deadliest and most destructive hurricane of the 2012 Atlantic hurricane season.

Our office received \$2.4 million for oversight of DOI contracts and grants related to Hurricane Sandy cleanup efforts. We completed 16 audits, 7 management advisories, and 2 inspections, resulting in \$14.56 million in questioned costs and \$1.7 million in funds recovered. We made and closed 83 recommendations.

# Key finding areas and number of associated recommendations:

- Pre-Award Process and Contractor/Grantee Selection (10 recommendations): inadequate competition, lack of independent Government cost estimate, and insufficient risk assessments.
- Insufficient Policies and Compliance Issues by Contractors/Grantees (15 recommendations): deficient accounting systems, commingling of funds, insufficient policies and procedures, and noncompliance with contract or grant terms.
- Unsupported Expenses (34 recommendations): inadequate timesheets, equipment purchased without sufficient documentation, and travel without required justifications.
- Post-Award Monitoring and Administration
   (24 recommendations): inadequate monitoring of
   (sub)contractor or (sub)grantee activity, failure to
   submit required reports, inadequate recordkeeping,
   and inadequate invoice reviews.

## DOI received \$787 million



Financial awards for disaster response are higher risk because they are often awarded quickly, add unplanned work for awarding officials and staff, and can be awarded without competitive bidding. These factors all require careful oversight of award administration and management.

# REPORT FRAUD, WASTE, ABUSE, AND MISMANAGEMENT

The Office of Inspector General (OIG) provides independent oversight and promotes integrity and accountability in the programs and operations of the U.S. Department of the Interior (DOI). One way we achieve this mission is by working with the people who contact us through our hotline.

#### WHO CAN REPORT?

Anyone with knowledge of potential fraud, waste, abuse, misconduct, or mismanagement involving DOI should contact the OIG hotline. This includes knowledge of potential misuse involving DOI grants and contracts.

#### **HOW DOES IT HELP?**

Every day, DOI employees and non-employees alike contact OIG, and the information they share can lead to reviews and investigations that result in accountability and positive change for DOI, its employees, and the public.

#### WHO IS PROTECTED?

Anyone may request confidentiality. The Privacy Act, the Inspector General Act, and other applicable laws protect complainants. Specifically, 5 U.S.C. § 407(b) states that the Inspector General shall not disclose the identity of a DOI employee who reports an allegation or provides information without the employee's consent, unless the Inspector General determines that disclosure is unavoidable during the course of the investigation. By law, Federal employees may not take or threaten to take a personnel action because of whistleblowing or the exercise of a lawful appeal, complaint, or grievance right. Non-DOI employees who report allegations may also specifically request confidentiality.
